


### 1. eHealth Kerala - Vital Statistics

### 2. Highlights



- The Alappuzha district is at position 2 in overall performance ranking of districts based on PHCs/FHCs.
  - Reception module is functional in 13 out of 15 PHCs/FHCs in the district.
- District is at :
- - position 2 in UHID Visits (53%).
  - - position 4 in Doctor Consultation(82%).
  - - position 2 in Pharmacy Usage(71%).



- The district remains at position 8 in online appointment booking.
- The district remains in 7th position in reach rank which indicates UHID registration proportionate to the population.
- The district is at position 5 in house survey completion(4%) and at position 8 in member survey completion(0.05%).


## 3. eHealth - District Ranking Matrix Based on Performance of PHCs/FHCs

The ranking matrix showcase the district performance in providing eHealth services through PHCs/FHCs based on five different parameters. These parameters include whether the reception module is started or not, UHID Visits, Doctor Consultation, Pharmacy Usage and Lab Usage. Based on the ranking, the districts are classified into three broad categories, the best performing districts, the average performing districts and the low performing districts.

The best performing districts should strive to continue to remain in the same position, whereas the average performing as well as the low performing districts should strive to reach to the 'top four' league.



The Alappuzha district is at position 2 in UHID visits with the value of 53%.









**5. Percentage of Online Appointment Booking in Hospitals**


District-wise count of online appointments taken during the month of July '22. Alappuzha district stands at 8th position in the case of online appointments.
