#### 2. Highlights



- 1. An increase in UHID Visit% was observed in November, with the percentage rising from 47% to 51%.
- 2. The percentage of lab orders placed by doctors increased by 1% in November, rising from 28% to 29%
- 3. Pharmacy prescriptions remained unchanged in November compared to the previous month.
- 4. The district ranked 5th in the district-wise percentage of online appointments taken up for OP visits, with nearly 1.1%.
- 5. Family Health Centre Meenachil has secured the top position in the eHealth institution-level ranking.



- Kottayam (KTM) district ranks 8th overall in eHealth service delivery among all DHS and NHM institutions, excluding institutions that offer only Reception/Advance Appointment services.
- 2. CHC Erumely records the lowest UHID percentage among institutions.
- CHC Erumely has the lowest consultation %,FHC
  Karukachal has the lowest Pharmacy prescriptions%
  and GH Kanjirappally has the lowest Lab Orders by
  Doctors %.
- 4. OP consultation reduced from 57% to 55% in November, marking a 2% decline.

The ranking matrix showcases the performance of districts in providing eHealth services through all institutions (excluding Medical Colleges) based on six different parameters.

These parameters include:

- 1. Percentage of institutions where the reception module is currently using (except institution started with VPN)
- 2. Percentage of UHID Visits.
- 3. Percentage of Doctor Consultations.
- 4. Percentage of Pharmacy Prescriptions by doctors.
- 5. Percentage of lab orders by doctors.
- 6. Percentage of Live Institutions.

Weightage is assigned to the percentages calculated in intervals of 10. The rank is determined based on the sum of these weightages.

The top-performing districts should aim to maintain their positions, while the average and low-performing districts should strive to reach the 'top four' league.



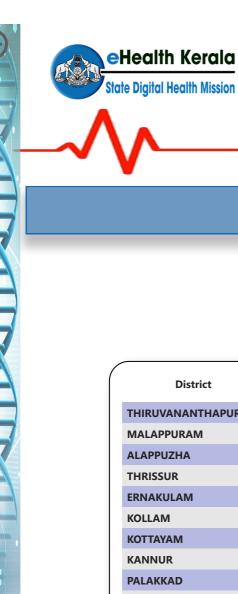

## 6. 1 Online Appointment Booking in Hospitals (except Medical Colleges)
